

**FULL OFFICIAL RULES
RENEW YOUR HOME SWEEPSTAKES
SPONSORED BY RENEWAL BY ANDERSEN**

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN TO ELIGIBLE RESIDENTS OF THE UNITED STATES AND CANADA WHO ARE AT LEAST THE AGE OF MAJORITY AND RESIDING IN THE ELIGIBLE GEOGRAPHIC AREA. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

- Promotional Period:** The Renew Your Home Sweepstakes (the "Promotion") is a series of four separate sweepstakes periods: Period One commences at 12:00:01AM Eastern Standard Time ("EST") on January 13, 2021 and ends at 11:59:59PM EST on April 13, 2021 ("Promotion Period One"), Period Two commences at 12:00:01AM EST on April 14, 2021 and ends at 11:59:59PM EST on July 13, 2021 ("Promotion Period Two"), Period Three commences at 12:00:01AM EST on July 14, 2021 and ends at 11:59:59PM EST on October 12, 2021 ("Promotion Period Three"), Period Four commences at 12:00:01AM EST on October 13, 2021 and ends at 11:59:59PM EST on January 11, 2022 ("Promotion Period Four"). Promotion Period One, Promotion Period Two, Promotion Period Three and Promotion Period Four shall collectively be referred to as the "Promotion Periods". These Official Rules shall serve as the official rules for each of these four separate Promotion Periods. Each of the four Promotion Periods constitutes a separate pool of entries and are therefore separate promotions. All Promotion entries for a respective Promotion Period must be received prior to the end time and date specified for such Promotion Period stated above. Entries submitted past the expiration of the respective Promotion Period will be accepted for the subsequent Promotion Period, so long as it is not Promotion Period Four. If an entry is submitted past the expiration of Promotion Period Four, then the entry will not be accepted and will be destroyed. The Promotion consists of a Grand Prize Sweepstakes (the "Sweepstakes") and a weekly sweepstakes (the "Weekly Sweepstakes"). A Grand Prize Sweepstakes prize will be awarded at the conclusion of each Promotion Period and a Weekly Sweepstakes prize will be awarded at the conclusion of each week of each Promotion Period. A promotional day ("day") as defined in these official rules is from 12:00:01AM EST to 11:59:59PM EST.
- Administrator/Sponsor:** The Promotion shall be administered by Brandmovers, Inc. 590 Means St., Suite 250, Atlanta, GA 30318 ("BRANDMOVERS" or "Administrator") and the sponsor is Renewal by Andersen LLC, 9900 Jamaica Avenue South, Cottage Grove, MN 55016 ("Sponsor").
- Eligibility:** The Promotion is open only to residents of the 50 United States and District of Columbia ("DC"), British Columbia and Ontario, Canada, who currently reside in a zip code or postal code which houses a Renewal by Andersen vendor, and who are at least the age of majority in the state/province of residency at the time of entry. Void outside of the 50 US states and DC, British Columbia and Ontario, Canada, and where prohibited. Potential participants may check the eligibility of their zip code/postal code

by visiting renewalbyandersen.com, and inputting their zip code into the respective field. Employees (and their immediate families (i.e., parents, spouse, children, siblings, grandparents, step parents, step children and step siblings and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of BRANDMOVERS and Sponsor, and each of their respective parents, affiliated companies, sponsors, subsidiaries, advertising and promotion agencies and third party fulfillment or judging agencies (collectively, the "Promotion Entities") are not eligible to enter or win the Promotion.

4. **How to Enter:** During the Promotion Period, complete the entry form available at a participating Renewal by Andersen trade show and place completed entry in the on-site entry box (for Sweepstakes Entry only) or visit renewalbyandersen.com and follow the links and instructions to navigate to the sweeps page of the site, and complete the required registration fields.
 - I. **Sweepstakes Entry:** Complete and submit the registration including a valid home address. P.O. Boxes are not permitted. Follow the on-screen instructions provided to: (a) register with Sponsor by completing all required fields contained on the Website ("Registration"); and (b) electronically agree to accept these Official Rules ("Rules") (collectively, "Online Entry"). You automatically will receive one (1) entry into the Sweepstakes. Limit: Each participant may enter one (1) time each Promotional Day. Only one entry allowed per email address. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder. Non-winning entries from each Promotion Period will not be carried over into subsequent Promotion Periods. For example, at the conclusion of Promotion Period One, entries from Promotion Period One will not be transferred to Promotion Period Two.
 - II. **Weekly Drawing:** Upon completing an initial Online Entry into the Sweepstakes, and for each subsequent successful log-in, the Entrant will automatically advance to the Thank You screen and have the option to receive one (1) Weekly Drawing Entry ("Weekly Drawing Entry") for that day. To enter the Entrant must follow the on-screen instructions and click on a share icon. Subject to verification of eligibility and compliance with these Rules.

5. **Grand Prize:** Exactly one (1) Grand Prize will be awarded in connection with the Grand Prize Sweepstakes portion of the Promotion (“Grand Prize”) during each Promotion Period. One (1) Grand Prize Winner (“Grand Prize Winner”) will be randomly drawn from among all eligible Entries received during that Promotion Period. Grand Prize winner will be selected by random drawing from among all eligible entries received. Random drawing will be held on or about the dates specified below: Promotion Period One – April 14, 2021 (“Drawing Date One”), Promotion Period Two – July 14, 2021 (“Drawing Date Two”), Promotion Period Three October 13, 2021 (“Drawing Date Three”), Promotion Period Four – January 12, 2022 (“Drawing Date Four”).

Grand Prize includes one (1) voucher usable for Renewal by Andersen® products and accompanying installation awarded in the form of a Gift Certificate (voucher expires 12 months after issuance). Approximate Retail Value: \$10,000. Prize is non-transferable except only with Sponsor’s prior written consent. No substitution of prize will be made except as provided herein at the Sponsor’s sole discretion. The number of eligible entries received during each respective Promotion Period will determine the odds of winning a Grand Prize. Sponsor reserves the right to substitute the prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated with prize receipt and/or use of the prize.

Total ARV of all Grand Prizes to be awarded in this Promotion is \$40,000.

6. **Weekly Prize:** Exactly thirteen (13) weekly prizes will be awarded in connection with the Weekly Prize portion of the Promotion during Promotion Period One and exactly thirteen (13) weekly prizes will be awarded in connection with the Weekly Sweepstakes portion of the Promotion during Promotion Periods Two, Three and Four (“Weekly Prize”).
- I. **First Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the first week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the first week in each Promotion Period (“Weekly Drawing Date One”).
 - II. **Second Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the second week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the second week in each Promotion Period (“Weekly Drawing Date Two”).
 - III. **Third Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the third week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the third week in each Promotion Period (“Weekly Drawing Date Three”).

- IV. **Fourth Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the fourth week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the fourth week in each Promotion Period (“Weekly Drawing Date Four”).
- V. **Fifth Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the fifth week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the fifth week in each Promotion Period (“Weekly Drawing Date Five”).
- VI. **Sixth Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the sixth week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the sixth week in each Promotion Period (“Weekly Drawing Date Six”).
- VII. **Seventh Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the seventh week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the seventh week in each Promotion Period (“Weekly Drawing Date Seven”).
- VIII. **Eighth Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the eighth week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the eighth week in each Promotion Period (“Weekly Drawing Date Eight”).
- IX. **Ninth Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the ninth week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the ninth week in each Promotion Period (“Weekly Drawing Date Nine”).
- X. **Tenth Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the tenth week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the tenth week in each Promotion Period (“Weekly Drawing Date Ten”).
- XI. **Eleventh Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the eleventh week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the eleventh week in each Promotion Period (“Weekly Drawing Date Eleven”).

- XII. **Twelfth Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the twelfth week in each Promotion Period. Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the twelfth week in each Promotion Period (“Weekly Drawing Date Twelve”).
- XIII. **Thirteenth Weekly Prize will be awarded.** One (1) Weekly Winner (“Weekly Winner”) will be randomly drawn from among all eligible Entries received between Sunday and Saturday of the thirteenth week in each Promotion Period. The potential Weekly Prize winner will be selected by random drawing to be held on or about the Tuesday following the thirteenth week in each Promotion Period (“Weekly Drawing Date Thirteen”).
- XIV. Weekly Prize consists of one (1) re-loadable \$25 Starbucks Gift Card. Prize is non-transferable and no substitution will be made except as provided herein at the Sponsor’s sole discretion. Sponsor reserves the right to substitute the prize for one of equal or greater value if the designated prize should become unavailable for any reason. The number of eligible entries received during the applicable week will determine the odds of winning a Weekly Prize. Non-winning entries from each Weekly Drawing will not be carried over into subsequent Weekly Drawing. Participants will be required to submit a new Entry for each Weekly Drawing. Winner is responsible for all taxes and fees associated with prize receipt and/or use of the prize. Starbucks is not affiliated with nor is it an endorser of this Promotion.

Approximate Retail Value of all Weekly Prizes to be won during one Promotion Period is \$325.

Approximate Retail Value of all Weekly Prizes to be won during all four of the Promotion Periods is \$1,300.

Approximate Retail Value of ALL PRIZES to be won in this promotion is \$41,300

7. **Notification:** Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of the potential winner are final and binding in all matters related to the Promotion. The potential winner will be notified by mail, email or phone. Upon receiving the Winner notification response, Administrator may send each potential Winner an Affidavit of Eligibility and Publicity (where legal) and Liability Release (if a United States resident) OR a Declaration of Eligibility and Liability Release (if a Canadian resident), which will need to be completed, signed and returned to Administrator within seven (7) days of receipt of the Release. If a resident of Canada, the potential winner must also correctly answer a time-based mathematical skill-testing question by phone without assistance of any kind prior to and as a condition of being declared a winner. If any Prize notification or attempted notification is returned as undeliverable or if potential winner cannot be reached within seven (7) days of the first attempt to contact the potential winner, that Prize may be forfeited and awarded to an alternate Winner, time permitting. Administrator and

Sponsor are not responsible for lost, late, damaged, delayed, or illegible paperwork. By signing the Release, Winners acknowledge compliance with these Official Rules. If a resident of Canada, the alternate winner must also correctly answer a time-based mathematical skill testing question by phone or in person without assistance of any kind prior to and as a condition of being declared a winner. 10. **General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. By participating in this Promotion, each entrant and winner: (a) agrees to be bound by these Official Rules; (b) agrees that the decisions of the Administrator and Sponsor are final and binding; and 3) warrants that s/he is eligible to participate in this Promotion.

11. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Promotion, during the applicable Promotion Period. If the Sponsor discontinues the Promotion for any reason, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein.
